The Visegrad Cooperation of Central and Eastern European Countries was established on February 15, 1991, ten days before the end of the Warsaw Pact. The motivation was cooperation in the transition from totalitarianism to liberal democracy. 

TOTAL new installed capacity of Photovoltaics





TOTAL new installed capacity of Wind









Calculation of costs of public support of development of new RES *(type of RES and accumulation indicated)*






costs of public support for the development of new and for RES in operation
